LAYOUT ANALYSIS

- Note lighting conditions throughout your property


FAMILY CONSIDERATIONS

- Account for children, elderly, or disabled family members
- Establish clear communication protocols and signals
- Onsider pets and their behavior during emergencies
- Plan for visitors or guests who may be present



THREAT ASSESSMENT

- Research local crime statistics and patterns
- ldentify your most vulnerable times (work schedules, travel)
- Onsider environmental factors (rural vs. Urban, neighbors)





PRO TIP:

Your intended use for home protection—whether it's focused on deterrence, early warning, or active defense—will shape every decision, from the type of equipment you choose to the features you prioritize.





DETERRENCE (FIRST LINE)

- Install visible security signage and lighting
- Maintain clear sight lines around your property
- Use landscaping strategically (thorny bushes under windows)
- Consider security cameras and motion sensors


DETECTION (EARLY WARNING)

- Install quality door and window alarms
- Motion detector lights with battery backup
- Security system with monitoring service
- Train family to recognize warning signs



DELAY (SLOW INTRUDERS)

- Reinforce doors with quality locks and strike plates
- Security film on ground-floor windows
- Door security bars or braces
- Safe room preparation with communication access





PRO TIP:

Each layer forces criminals to make noise, take time, and increases their chance of being caught or giving up.





NON-LETHAL OPTIONS

- High-quality flashlights in multiple locations
- Personal alarms and whistles
- Pepper spray or tasers (where legal)
- Strong locks on bedroom doors for safe rooms

LETHAL FORCE CONSIDERATIONS

- Understand your state's castle doctrine laws
- Select appropriate firearms for home defense
- Plan for safe storage yet quick access
- Onsider over-penetration in your home's construction



COMMUNICATION PLAN

- Cell phone with emergency contacts programmed
- Code words for family members
- Olear instructions for calling 911
